



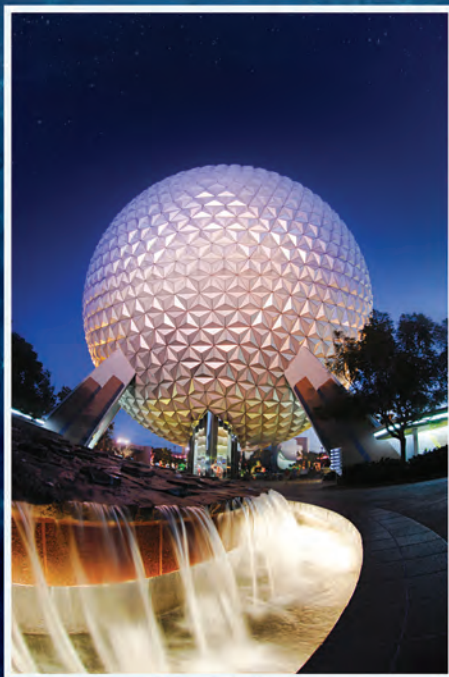

**SYNOPSIS:** This headache medicine symposium will review the new International Classification of Headache Disorders and the differential diagnosis of headache. It will also provide an update on the basic science mechanisms of migraine and other headache disorders. There will be a thorough review of the diagnostic medical evaluation and physical examination of patients with headache, as well as the role of diagnostic studies for the evaluation of headache. A review of the more common as well as the dangerous and unusual headache disorders will be presented. An update will be presented on the current treatment modalities for headache; including, acute and preventative pharmacotherapy, injection therapy (including botulinum toxin), behavioral medicine therapy, injection therapy, neuromodulation and surgical therapy.

**Pre-Conference II: Effective Diagnosis and Management of TMD****Fantasia K-L**

**SYNOPSIS:** This clinically oriented program is designed to help participants more effectively treat their TMD patients. We will first review the initial patient evaluation and provide a recommended treatment protocol for integrating and utilizing multidisciplinary TMD therapies. This sequence will then be applied to 15 documented cases in which patient symptoms and clinical evaluation results are presented, and potential diagnoses and treatments are discussed. Several of these patients present with symptoms similar to TMD, but the symptoms are due to other diagnoses (e.g., acute pulpalgia and sinusitis); participants will learn how to differentiate these disorders from TMD through history and clinical evaluation. The TMD cases range with varied symptom patterns and diagnoses, from muscle disorders to TMJ disorders, including acute closed lock and, lateral and medial pterygoid spasms. Finally, the various forms of intraoral appliances are discussed, enabling participants to reflect on their currently used appliance and how they may want to vary their appliances in their practice.

**LEARNING OBJECTIVES:** The course is designed to help participants more cost effectively obtain maximal therapeutic benefit for their TMD patients. Participants will:

1. Learn to identify patients who generally will not respond well to traditional TMD therapy and how that can be changed.
2. Understand when to suspect symptoms similar to TMD are actually due to another disorder.
3. Gain new insight into how to more effectively treat the various forms of TMD.
4. Understand when to utilize the various multidisciplinary TMD therapies.
5. Comprehend the various intraoral appliances options and determine which is most effective for their practices and various patients.

**SYNOPSIS:** This program will provide the participant with the opportunity to complete a detailed dissection of the superficial structures of the face, the masticatory musculature, the temporomandibular joint, oral cavity, nasal air passageways, and all parts of the pharynx. - **Author(s):** (Authors should be listed by last name, followed by first name initials, after the abstract title. The name of the presenting author should be underlined).
- **Affiliations:** (Indicate any affiliations to a University/College or Private Practitioners and city).
- **Aim of Investigation:** (aims/purpose, hypotheses, and goals of the investigation).
- **Methods:** (brief description of experimental procedures including statistics, study design and analysis).
- **Results:** (findings of statistical analysis).
- **Conclusions:** (one or two major conclusions that are supported by results)
- **Acknowledgements and/or Funding Source:** (include reference to grant support, (including grant number), and disclosure of any financial relationship the author may have with the manufacturer/supplier of any commercial products or services).

All abstracts MUST be accompanied by the Abstract Submission Form.
