**SYNOPSIS:** The morning session will give the orofacial pain specialist new and exciting information about recent research of cervical muscle pathology and its correlation to orofacial pain. In addition, research presentation on cervical and oral dystonia will add to the clinicians understanding and the ability to recognize these movement disorders and comprise an adequate treatment plan. The afternoon session will focus on comprehensive and evidence based cervical spine muscle rehabilitation for patients with orofacial pain.

9:30 am Cervical Muscle Pathology and Orofacial Pain."

**SYNOPSIS:** (confirmed by speaker) In my presentation, I will discuss how cervical muscle pathology promotes cellular changes that increase the risk of development of a chronic pain state involving sensitization of trigeminal ganglion neurons. Specifically, I will present data to demonstrate that cervical muscle pathology/inflammation promotes neuron-glia activation associated with central sensitization in the upper spinal cord that leads to peripheral sensitization of primary trigeminal nociceptors – bidirectional signaling. The role of elevated spinal cord levels of the neuropeptide CGRP in mediating central and peripheral sensitization in models of migraine and TMD pathology will be discussed. In addition, the differential effect of gender will be highlighted to help explain the higher prevalence of orofacial pain in females.

#### 1:00 pm Therapeutic Exercises for Patients with Headache and Chronic Cervical Pain.

It is now known that patients with tension-type or cervicogenic headache, as well as chronic neck pain present with an array of neuromuscular changes that are not substantially different from those observed in patients with mechanical neck pain. Studies have reported that patients with cervicogenic headache and chronic neck pain showed deficits in strength and endurance of cervical flexor and extensor muscles. (Watson and Trott, 1993; Dumas et al., 2001; Jull et al., 2007a). Therefore, low-load therapeutic exercises emphasize motor control rather than muscle strength are advocated for an effective management of patients presenting with cervicogenic and tension-type headache, as well as chronic cervical pain. This lecture/lab aims to cover this topic and provide specific cervical and scapular exercises to reduce or eliminate head, neck and face pain.

- The scientific committee will give high preference to original clinical or basic research abstracts of Randomized Controlled Trials and Observational Studies (Cohort study, Case control study).

The body of the abstracts must not exceed 250 words and must contain the following eight sections IN THIS ORDER and labeled as noted:

- Title:** (Title text should be in bolded font. Capitalize the first word, last word, all significant words and all proper nouns contained in the title and sub-title. Do NOT use all capitals. Clearly indicate the nature of the study in the title (i.e.: case-control, randomized controlled trial, etc.).

- Author(s):** (Authors should be listed by last name, followed by first name initials, after the abstract title. The name of the presenting author should be underlined).
- Affiliations:** (Indicate any affiliations to a University/College or Private Practitioners and city).
- Aim of Investigation:** (aims/purpose, hypotheses, and goals of the investigation).
- Methods:** (brief description of experimental procedures including statistics, study design and analysis).
- Results:** (findings of statistical analysis).
- Conclusions:** (one or two major conclusions that are supported by results)
- Acknowledgements and/or Funding Source:** (include reference to grant support, (including grant number), and disclosure of any financial relationship the author may have with the manufacturer/supplier of any commercial products or services).

### Submission Requirements:

All abstracts MUST be accompanied by the Abstract Submission Form.

described above and approved by council for student/initiatory membership. A full-time orofacial pain post-graduate or residency program must be consistent with current CODA accreditation standards.
