Opioids - How to Fight This War and Alternative Options - Lori Reisner, PharmD

SYNOPSIS: Opioids have recently emerged as the leading cause of death for young-tomiddle age adults in the United States, exceeding deaths from accidental injury, cancer and cardiovascular disease. Importantly, new studies also show that young adults and teens are increasingly developing opioid use disorders, many of these following surgery and other medical or dental interventions. It is estimated that as many as 30% of some populations are unable to discontinue taking opioids intended for short-term use following a procedure. To stem the tide of death and injury due to opioids, regulatory restrictions are either mandated or under consideration for prescribers. In addition, guidelines from the Center for Disease Control (CDC) and professional societies are encouraging the use of alternatives to opioids for acute pain, and limiting the duration of prescribing as well. For this reason, prescribers should be familiar with their alternative choices when confronted with an acute pain, as well as differences between opioids that may influence the ability to taper off of them. This session will review multimodal regimens for acute pain and discuss investigational new analgesics that may aid in the future management of pain.

SYNOPSIS: Sleep and pain have been shown to have bidirectional relationships. what ever we do to affect pain (medications, change of diet, behavior modification etc) does affect pain and vice versa. SYNOPSIS: Sleep disordered bruxism has been classified as a "Sleep related movement disorder" by the AASM. We have enough evidence that this is not a "habit". We will discuss the latest in literature in the enigma of bruxism. The current suggestions and management options with limitations will be discussed briefly.

Myofunctional Therapy, Indicators and Relevance to Orofacial Pain - Jennifer Hobson, PT, DPT, MTC, CFC, CMTPT

SYNOPSIS: The objectives of this presentation are to give the audience an awareness of what myofunctional therapy is and how to identify myofunctional disorders in your own orofacial pain patients. Most craniofacial pain patients are originally breathing disorder patients and once the breathing dysfunction is addressed, many of the orofacial pain, head and neck pain, and breathing symptoms will resolve. This talk will include clinical cases and will review assessment tools and treatment techniques to improve airway patency, head and neck posture, and breathing mechanics. Other topics that will be briefly mentioned are: recent supportive myofunctional therapy medical literature, ankyloglossia and the effects that oral tethered tissue have on head and neck breathing dysfunctions, the possible need for lingual and labial frenectomies, mouth breathing and sleep apnea, and the importance of a multidisciplinary team.

Cannabinoids - Lori Reisner, PharmD

SYNOPSIS: Across the Unites States and in other countries, cannabinoids have been approved or are under consideration for legalization. They have been promoted for a variety of conditions including chronic pain syndromes, multiple sclerosis, glaucoma, anxiety disorders, and other uses. Patient reports of their efficacy are variable and dependent on the choice of agent (e.g., cannabidiol versus tetrahydrocannabinol) as well as the delivery system. Such delivery systems include inhalation, topical application or oral ingestion. Unfortunately, comparative studies are sparse, and lack of regulatory oversight contributes to the non-standardization of products. This session will review the literature on commercial and non-commercial forms of medical cannabinoids, as well as those from various sources (hemp or marijuana). Examples of changes in regulations regarding cannabinoids and their impact on availability will also be discussed.

Criteria for Selection

- Abstracts must be original scientific material that has not been previously published or presented at any other national or international meeting.

- Case reports may be accepted only if the scientific committee determines that the material presented is of high interest and high quality information.

Author(s): (Authors should be listed by last name, followed by first name initials, after the abstract title. The name of the presenting author should be underlined)

Affiliations: (Indicate any affiliations to a University/College or Private Practitioners and city)

Aim of Investigation: (aims/purpose, hypotheses, and goals of the investigation)

Methods: (brief description of experimental procedures including statistics, study design and analysis)

Results: (findings of statistical analysis)

Conclusions: (one or two major conclusions that are supported by results)

Acknowledgments and/or Funding Source: (include reference to grant support, including grant number, and disclosure of any financial relationship the author may have with the manufacturer/supplier of any commercial products or services)

Additional Formatting Requirements

- Abstracts must be written in English language.
- Font should be Times New Roman, font size should be 12, and font color should be black.
- No tables or illustrations may be included in abstracts.
- Only generic drug names should be used.
- Results and conclusions should be included at the time of submission. If these are missing, the abstract will be rejected.

All accepted submitters are required to register for the meeting.
