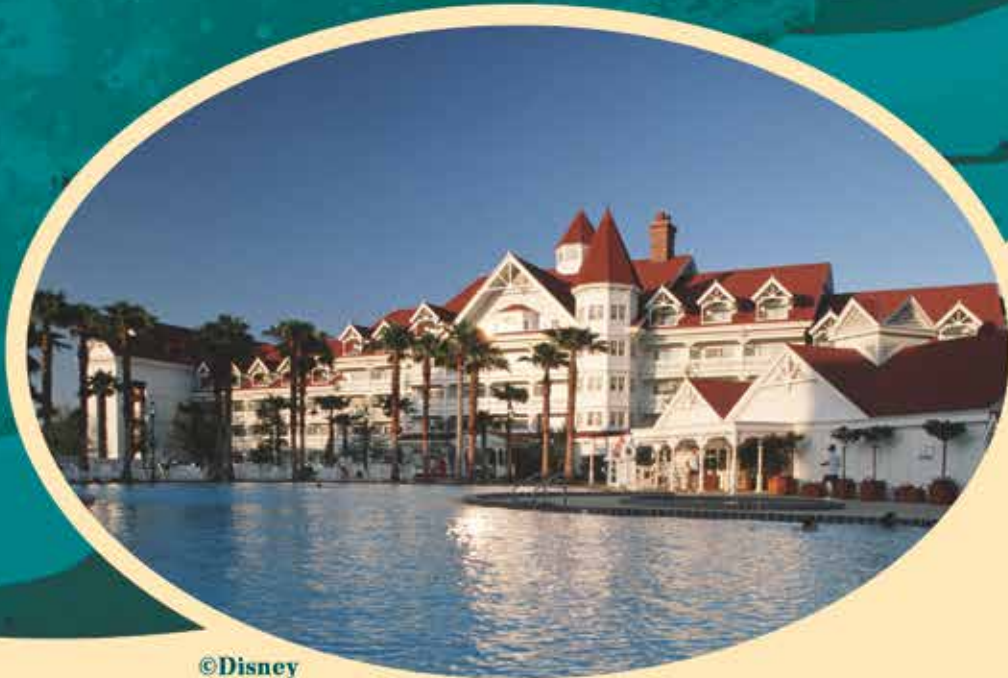

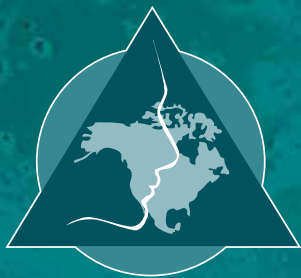

## PRECONFERENCE WORKSHOPS

**SYNOPSIS:** Our overall health and well-being are directly related to our dietary choices. Poor choices equal poor health while good choices promote and maintain health of all our physiological systems and minimize inflammation. This includes not only what foods we eat but also what beverages we consume daily since both contribute key nutrients and molecules to minimize inflammation, boost cellular function and protect our proteins, DNA, and lipids from damage. Yet, we are experiencing a global epidemic of obesity and diabetes. Equally alarming is the report that 30% of Americans are living with some form of severe or chronic pain, which means that more people are living in chronic pain than with cancer, heart disease, and diabetes combined. Hence, despite almost year-round access to foods from all over the world, our overall health is declining, and more people are living in chronic pain. These pathological conditions are mediated by changes at the cellular and molecular levels and are greatly influenced by our diet. Dr. Paul Durham will review the importance and benefit of consuming nutritional foods enriched in polyphenols and natural fiber and beverages with high antioxidant capacity to promote the health of our cells as well as commensal oral and intestinal bacteria. In addition, he will provide information on the essential role of minerals, vitamins, and micronutrients, for maintaining basic cellular functions. Examples will be provided regarding how dietary supplements can significantly alter and even reverse disease progression and help to manage chronic pain and inflammation. Current findings will be shared on dietary supplements reported to improve oral health and function to directly modulate the activity of trigeminal neurons and glial cells.

**SYNOPSIS:** Participants can choose diagnostic tools to recognize headaches like migraine, tension-type headache and headache attributed to TMD based on scientific evidence.

- Participants can discuss which therapy should be applied for different patients with TMD and headaches, based on scientific evidence.

**Lecture 3: Measuring Physical and Emotional Health: The Missing Pieces for Comprehensive Pain Management**

**SYNOPSIS:** Patients with complex, chronic pain conditions are a difficult population to manage.

The objectives of this presentation are:

1. Discuss the risk factors of developing and maintaining pain to support the classification of chronic pain as a systemic disease
2. Demonstrate the interplay between the risk factors of chronic pain
3. Present the clinically efficient measures used in the High Point University Pro Bono Physical Therapy Clinic to capture these variables in our clinical population
4. Describe the unique patient profiles discovered through data analysis of these measures in our clinical population with pain complaints as well as those presenting with headache
5. Present behavior and communication strategies as an effective and necessary intervention for patients with chronic pain and headache

**Pre-Conference III: Dentists and Orofacial Pain: CBCT to The Rescue!**

**SYNOPSIS:** Undiagnosed orofacial pain presents the dentist with one of the most common and complex problem areas encountered in the dental office. While dentists are expert at

the diagnosis and management of acute pulpal and periodontal origins, other sources of pain like those from headache, sinus problems, neuralgias, and temporomandibular joint disorders can be much more confusing. Nevertheless, the patient expects the dentist to be an expert in all of these areas, and to diagnose and manage their pain complaints. In some cases, cone beam CT imaging can help the dentist identify the most likely source of the pain.

This course presents a simple, systematic approach to evaluation of their scan data to help the clinician with their clinical decision-making. Examples of cases to illustrate the importance of a proper diagnostic work-up will be presented. The valuable contribution of cone beam 3-D imaging to the diagnosis of the patient's pain complaint will be presented.

Upon completion of this program the dentist will:

- Understand the basic principles of CBCT
- Understand the requirement for systematic review of their scan data
- Understand the valuable role that cone beam imaging plays in helping identify sources of orofacial pain
- Identify CBCT radiographic findings related to certain pain symptoms

**The Use of Arthrocentesis in the Treatment of****Temporomandibular Joint Disease** - Andrew Read-Fuller, DDS, MS

**SYNOPSIS:** Arthrocentesis is an invaluable procedure in the management algorithm for temporomandibular joint disease, particularly in the early Wilkes stages. This objectives of this course are to understand the appropriate workup and indications for the procedure, review the proper technique and discuss the potential complications as well as important pearls and pitfalls to maximize clinical outcomes and improve patient satisfaction. Additionally, the relevant literature supporting the use of arthrocentesis will be used throughout the presentation to help the practitioner determine when best to recommend the procedure in the context of other non-surgical and surgical treatments for TMJ disease.

**Medical Billing: Pearls and Pitfalls** - Rose Nierman

**SYNOPSIS:** As dentistry continues to shift towards oral-systemic wellness, more dental procedures are being recognized as medically necessary and being covered under major health insurance plans and policies. Dental practices are recognizing the significant benefits to offering medical insurance reimbursement such as increased case acceptance, expanded referral networks and increased revenue. Cross-coding practices that utilize the patient's medical insurance are maximizing the patient's benefits and giving them easier access to much needed care. In this lecture, attendees will learn how to incorporate cross-coding and medical billing into their office. Discussion will include the services that can potentially be covered by medical insurance, including procedures such as frenectomies, mucositis and pain conditions. Also covered will be the requirements for receiving reimbursement and a step-by-step guide for how to get started.

##### Extra Oral Injections and Prolotherapy

**SYNOPSIS:** It is impossible to call your patient care comprehensive without diagnostic and therapeutic injections in the head and neck muscles, tendons and in the TMJ. A review of what's old, what's new will be discussed. How and where to do injections including dry needling, lidocaine and prolotherapy will be reviewed. Is it evidence based?

##### Identifying Obstructive Sleep Apnea Patients Responsive to Oral Appliances

– Ali Azarbarzin, MD

**SYNOPSIS:** Obstructive sleep apnea (OSA) is a common disorder, with roughly 1 in 5 adults estimated to have at least mild OSA and 1 in 15 estimated to have at least moderate OSA (Young 2002). OSA causes a number of adverse cardiovascular and neurocognitive consequences, including stroke, heart failure, excessive daytime sleepiness, and car accident. While it is possible to splint the airway open during sleep with positive airway pressure (PAP) therapy, only half of the patients tolerate PAP. Past research provides compelling evidence regarding efficacy of Mandibular Advancement Splints. However, routine clinical variables obtained from polysomnography (PSG), such as apnea-hypopnea index (AHI) poorly predict the success of these non-PAP therapies, mainly due to the differences in endotypic traits that cause OSA. In my lecture, "Identifying Obstructive Sleep Apnea Patients Responsive to Oral Appliances," I will be presenting our recent work aiming to identify the physiological markers that predict responses to mandibular advancement therapies.

##### Bruxism Workshop: Assessment and Management Guidelines

– Daniele Manfredini, DDS, MSc, PhD

**SYNOPSIS:** Approaches for assessing bruxism can be distinguished as non-instrumental or instrumental. Non-instrumental approaches for assessing bruxism include self-report (questionnaires, oral history) and clinical inspection, both for sleep and awake bruxism. Instrumental approaches for assessment are currently available for both forms of bruxism. Measurement of jaw muscle activity via polysomnography (PSG) or electromyography (EMG) is the standard of reference for sleep bruxism. Ecological momentary assessment (experience sampling methodology [EMA/ESM]) app-based assessments for real time subjective information about masticatory muscle activities at certain time points during the awake phase can also provide evidence of awake bruxism. For various reasons, it must be remarked that using standard cut-off points for everyone for the 'gold-standard' assessment of sleep bruxism or non-sleep bruxism should not be considered optimal for clinical use in otherwise healthy individuals. This issue is best exemplified by the still inconclusive literature on the polysomnographic assessment of sleep bruxism and its clinical consequences. Within these premises, this workshop will also discuss the most recent literature on management of bruxism in adults. Currently, there is not enough evidence to define a standard of reference approach for treatment, especially considering the reigning confusion about the treatments oriented to eradicate bruxism causes and those aiming to manage the consequences. Thus, future studies on the indications for bruxism treatment are recommended. Until that, a so-called "Multiple-P" approach including Pep Talk (i.e., counseling), Plates (i.e., oral appliances), Psychology, Physiotherapy, and Pharmacology, is the best available, good-sense, option to manage bruxism and its consequences in the clinical setting.

The AAOP invites members and non-members to submit abstracts to be considered for poster presentation at the AAOP 2020 Annual Scientific Meeting at Disney's Grand Floridian Resort & Spa in Orlando, FL. The presenting author of an accepted abstract must register for the meeting and is required to be present at the requested time by the organizing scientific committee.

### Submission Deadline:

All abstracts must be received by **February 15, 2020**. They should be submitted by email to AAOP central office; admin@aaop.org. and to Mariona Mulet Pradera; mulet001@umn.edu. AAOP will confirm receipt of the abstract within a week. If you do not hear from AAOP, please send a follow up email.

### Criteria for Selection

- Abstracts must be original scientific material that has not been previously published or presented at any other national or international meeting.
- The scientific committee will give high preference to original clinical or basic research abstracts of Randomized Controlled Trials and Observational Studies (Cohort study, Case control study).
- Case reports may be accepted only if the scientific committee determines that the material presented is of high interest and high quality information.

### Formatting

- The body of the abstract must not exceed 250 words, including references, but excluding title and authors. If the abstract exceeds 250 words, it will be returned to the author to shorten it.
- The body of the abstract must contain the following eight sections IN THIS ORDER and labeled as noted:

**Title:** (Title text should be in bolded font. Capitalize the first word and all proper nouns contained in the title and sub-title. Do NOT use all capitals. Clearly indicate the nature of the study in the title (i.e.: case-control, randomized controlled trial, etc.)

**Author(s):** (Authors should be listed by last name, followed by first name initials, after the abstract title. The name of the presenting author should be underlined)

**Affiliations:** (Indicate any affiliations to a University/College or Private Practitioners and city)

**Aim of Investigation:** (aims/purpose, hypotheses, and goals of the investigation)

**Methods:** (brief description of experimental procedures including statistics, study design and analysis)

**Results:** (findings of statistical analysis)

**Conclusions:** (one or two major conclusions that are supported by results)

**Acknowledgments and/or Funding Source:** (include reference to grant support, including grant number, and disclosure of any financial relationship the author may have with the manufacturer/supplier of any commercial products or services)

### Additional Formatting Requirements

- Abstracts must be written in English language.
- Font should be Times New Roman, font size should be 12, and font color should be black.
- No tables or illustrations may be included in abstracts.
- Only generic drug names should be used.
- Results and conclusions should be included at the time of submission. If these are missing, the abstract will be rejected.

All accepted submitters are required to register for the meeting.

All submissions will be reviewed by the AAOP Abstract Committee.
